

# UAW-Ford Tuition Assistance for Active Employees

## Frequently Asked Questions

<b>Eligibility</b>	Who is eligible to use Tuition Assistance?	Full-time active UAW represented hourly employees who have acquired seniority (3 months of employment)
<b>Schools/Courses</b>	Are all schools/courses approved?	Not all school/courses/fees are covered by tuition assistance. It is strongly recommended to submit an application in advance to make sure selected school and course(s) are approved
<b>Deadlines</b>	What are the deadlines for using Tuition Assistance?	<ul style="list-style-type: none"> <li>ETAP applications must be submitted no later than 45 days after term start date.</li> <li>PDA classes must be approved prior to class start date.</li> <li>Book reimbursement must be submitted no later than 90 days after term start date</li> <li>Invoices requesting payment must be received by the NPC from the school no later than 9 months from term start date</li> </ul>
<b>Reimbursements</b>	Are reimbursements available?	No – With the exception of textbooks, Tuition Assistance is a prepayment program. UAW-Ford pays the school directly
<b>ETAP</b>	What is the Education Tuition Assistance Plan (ETAP)?	Up to <b>\$6,000/yr</b> for tuition/fees for approved courses leading to a certificate/diploma, or degree (Associate, Bachelor, Master, or PhD) from a regionally accredited school
<b>PDA</b>	What is Professional Development Assistance (PDA)?	Up to <b>\$2,700/yr</b> for job related courses including: <ul style="list-style-type: none"> <li>Industrial Readiness Certificate Program (IRCP)</li> <li>Labor Studies courses &amp; conferences (incl. online)</li> <li>Dale Carnegie, including online courses</li> <li>LJPR Financial Education Programs</li> </ul>
<b>EEC</b>	What are Educational Enrichment Courses (EEC)?	Up to <b>\$500/yr</b> for Continuing Education, Lifelong Learning, or Professional Development Courses (online included) at regionally accredited schools
<b>Textbooks</b>	Are textbooks covered?	Yes - <b>\$400/yr</b> may be used for textbooks Includes e-books, book rental, and books purchased through on-line retailers and applicable shipping costs
<b>Vouchers</b>	What is the Official Tuition Voucher?	Once classes are approved, an Official Tuition Voucher will be issued to the employee. The employee submits this to the school for payment
